About Working with Tickets that Fall under the Provisions of the Russian Government Regulation No 991

TO: Agents of Siberia Airlines, JSC

Dear Colleagues,

Please, be informed that due to the Russian Government Regulation No 991 as of July 06, 2020, the refund procedure of the tickets issued under the 421 stock before May 01, 2020, for travelling to/from China on/after February 01, 2020, and to/from other international and domestic destinations on/after March 18, 2020, has been changed.

If a passenger applies for refund of tickets issued under the 421 code before May 01, 2020, for travelling to/from China on/after February 01, 2020, and to/from other international and domestic destinations on/after March 18, 2020, a voucher (EMD 992) is issued according to the conditions of this Letter (table 1 below).

A Voucher issued in exchange of a ticket that falls under the RGR No 991 may be used to pay for a new ticket or additional services of the Carrier within three (3) years from the ticket flight departure date.

See Annex 1 to this Letter to check if a ticket falls under the RGR No 991.

When issuing a Voucher, the amount may be increased to the amount of EMDs previously issued to the passenger to pay for extra baggage or other additional services of the Carrier.

Any EMD 992 issued in exchange of a ticket that falls under the RGR No 991 shall have 'PP991' in the Tour Code (TMI/M1/FT-*PP991).

In three (3) years of the ticket flight departure date, a passenger may apply for refund of the monetary means that were not used to pay for a new ticket or Carrier's additional services.

The refund request may then be submitted:

- Personally at any Carrier's Representation Office / S7 Service, LLC, office;
- Via the official website <u>www.s7.ru</u> using Contact Form (for tickets issued via the website www.s7.ru or S7 Call Centre)
- By sending a usual mail to the following address: Mozzherina prospect, 10, office 201, Town of Ob, Novosibirsk region, Russia, 633104

Note:

A passenger from a special category:

- Disabled persons and an accompanying person;
- Veterans of the Great Patriotic War,
- a person who has a certificate of a large family or other documents confirming the status of a large family in the manner prescribed by regulatory legal acts of the Russian Federation, as well as members of a large family (spouse, minor children);

may apply for refund of the monetary means before the expiration of three (3) years from the flight departure date mentioned in the ticket as well as prior to the flight departure date mentioned in the ticket by any of the above ways.

Totally unused tickets issued for special category passengers may be refunded at the place of issuance (if technically possible), provided that such refund request was made before the departure date.

If refund request is made for a totally unused ticket after the departure date or for a partly used ticket, a special category passenger shall apply to the Carrier by any of the above ways.

When making a refund request for unused monetary means, a special category passenger must present a valid standard document confirming the fact of the disability, or the status of the veteran of the Great

Patriotic War, or the large family status. A disabled person and accompanying person shall make refund requests simultaneously.

A refund request must contain:

- a surname, name and patronymic name (if any) of the passenger (of a person who has paid for the ticket):
- identity document information;
- details of the document confirming the fact of the disability (if any), or the status of the veteran of the Great Patriotic War (if any), or the large family status (if any);
- date and place of birth;
- booking and/or ticket number;
- application date.

Refund of unused monetary means (fare and taxes) is made in full without any charges and deductions irrespective of the fare application rules (Basic or Flex).

Copies of document confirming the fact of the disability, or the status of the veteran of the Great Patriotic War, or the large family status shall be kept for three (3) years and may be requested by the Carrier.

Monetary means not used to pay for a new ticket or additional services of the Carrier are subject to the interest for the use of funds. Additional services amount included in the Voucher is not subject to the interest for the use of funds.

If a totally unused ticket is refunded prior to the first flight departure date mentioned in the ticket, than interest is not charged.

The amount of interest for the use of funds is determined by the key rate of the Central Bank of the Russian Federation in effect in the relevant periods.

Interest for the use of funds is charged starting from the date following the first unused coupon flight departure date till the date of the refund in the reservation system, but not later than four (4) years after the flight departure date mentioned in the ticket.

No interest is charged on monetary means used to pay for a new ticket or additional services of the Carrier.

A Voucher in exchange of a ticket is issued according to the valid Guidelines on Handling Traffic Documents Purchased with Travel Voucher and taking into account the provision hereof.
