## containing S7 flights to/from OVB-MUC and back

TO: Agents of Siberia Airlines, JSC

## Dear agents!

Please, be informed about the procedures of working with tickets issued on 421 stock and containing own flights S7 Airlines (S7) on routes Novosibirsk (OVB) - Munich (MUC) which depart in the period from the June 01, 2022 to the October 26, 2022 inclusively.

The tickets with **OVB - MUC** segments which depart in the period from the June 01, 2022 to the October 26, 2022 inclusively, according to passenger's wish are permitted:

1. Involuntary refund shall be provided at the place of tickets purchase in accordance with the type of payment specified in the ticket.

In case of involuntary refund of the tickets issued on stock of other carriers, passenger shall be redirected to the validating carrier.

- 2. Involuntary reissue may be for S7 own flights:
  - 1. The reservation shall be created in the minimum available RBD maintaining the class of service;
  - 2. New dates of carriage shall be within from 1 to 7 days before/after of the original dates;
  - 3. With a change of route:
    - a. the route OVB MUC may be changed to the route OVB DUS/ FRA
    - b. the route MUC OVB may be changed to the route DUS/ FRA OVB
    - c. the route OVB MUC may be changed to the route OVB-DME-MUC/ DUS/ BER/ FRA
    - d. the route MUC OVB may be changed to the route MUC/ DUS/ BER/ FRA DME -OVB
    - e. the route <CITY>-OVB-MUC may be changed to the route <CITY>-DME- MUC/DUS/BER/FRA
    - f. the route MUC-OVB-<CITY> may be changed to the route MUC/DUS/BER/FRA- DME-<CITY>
